Scope of work:-

1. EOI for submitting proposal of setting up operating and maintaining open Gym a Jogger Park Bathinda.

Terms & Conditions:

1. The interested parties can visit Jogger Park any time.
2. Any information required for preparing proposal can get from undersigned on any working day.
3. No payment will be made for this proposal.
4. The proposal should be complete including layout plan, estimate project cost detailed specifications & number of units to be installed.
5. Details safety measures which will be taken during operations.
6. Details of staff to be deployed.
7. The maximum land available shall be 20mX20m.
8. The maximum term/tenure shall be of 5 years.
9. Damage to greenery/plantation shall not be allowed.
10. The EOI shall clearly mention the amount of expected compensation & the form in which the compensation is expected.
11. The maximum monthly membership shall be Rs300/per member per month
12. The maintenance of site shall be carried out by the agency.
13. All expense for electric and water connection including monthly bills of the same will be borne by Agency.
14. The Agency/NGO will not be allowed to run any anti social activity in the premises.
15. No anti social or offensive advertisement shall be displayed.

16. MCB will display the SBM logo, MCB logo, social messages & user charges on the walls/ board as required by MCB.
17. The ownership of premises will vest with Govt..
18. If any time in future, the proposed premises will be required for any development activity in public interest the same shall be withdrawn from Agency/NGO and no claim shall be paid to Agency/NGO, in lieu of the same.
19. The site will be in good condition and easily accessible to general public.
20. If any of the condition is violated, MCB will take over the site & will run the same at his own or through any agency as deem fit and no cost will be given to NGO for renovation.
21. Agency will not change the purpose of site.
22. If any Court taken any decision with regard to advertisement, the same shall be binding on both the parties.
23. If any dispute arises, the decision of the Commissioner, Municipal Corporation shall be final and binding to both the parties.
